**Summary:** Legal aspects related to Old Age Psychiatry is an integral part of modern day practice, be it balancing between autonomy and vulnerability of the individual or advising legal profession when a crime may have been committed. While legal constructs are often different across countries, it is important to understand legal principles and discuss and debate how legal systems and processes can be optimised to serve older population. In this webinar our two experienced Old Age Psychiatrists will focus on forensic and civil aspects of law in relation to old age psychiatry and will explore legal systems in two countries in Europe, Sweden and United Kingdom.
